21. Evaluation and Comparison of Bids	21.1 In evaluating the Bids, the Employer shall determine for each Sealed Bid the evaluated Bid Price by adjusting any corrections for errors. Bids shall be checked by the Employer for any arithmetic errors. • COMPETITION SYSTEM

The 2025 SAFF Club Women's Championship is the first-ever regional women's club football tournament organized by the South Asian Football Federation (SAFF). Scheduled to take place in Kathmandu, Nepal, from 5 to 20 December 2025, the competition will feature five champion clubs from across South Asia — representing India, Nepal, Bangladesh, Bhutan, and Pakistan.

All matches will be held at the Dasharath Rangasala Stadium, with teams competing in a round-robin format, followed by a final between the top two sides. This inaugural event marks a major milestone in promoting women's club football development and regional cooperation within South Asia.

- It provides an international platform for top clubs from member associations of SAFF to compete regionally.
- The tournament also aligns with broader efforts by SAFF to raise standards, visibility and competitiveness of women's football in the region.
