<b>10. <b>12. Bid/Bid Security</b>	12.1 The Bidder shall furnish as part of its Sealed Bid, in original form, a bid security <b>as specified in the BDS</b> . In case of e-submission of Bid, the Bidder shall upload scanned copy of Bid security letter at the time of electronic submission of the Sealed Bid. The Bidder accepts that the scanned copy of the Bid security shall, for all purposes, be equal to the original. <p><b>14. Sealing and Marking of Bids</b></p>	<p>14.1 Bidders may submit their bids by electronically. If so <b>specified in the BDS.</b></p> <p>14.2 Bidders submitting Bids electronically shall follow the electronic bid submission procedure specified in the BDS</p>
<p><b>15. Deadline for Submission of Bids</b></p>	<p>15.1 Bids shall be delivered to the Employer at the address no later than the time and date specified in the BDS.</p>
<p><b>16. Late Bid</b></p>	<p>16.1 Any Bid received by the Employer after the deadline shall not be accepted and shall be returned unopened to the Bidder upon request.</p>

Process to be Confidential</b></p>	<p>19.1 Information relating to the examination, evaluation and comparison of Bids and recommendations for the award of a contract shall not be disclosed to Bidders or any other persons not officially concerned with such process until the award to the successful Bidder has been announced. Any efforts by the Bidder to influence the Employer in the Bid evaluation, comparison or contract award decisions may result in rejection of Bidder's Bid.</p>
<p><b>20. Examination of Bids</b></p>	<p>20.1 Prior to the detailed evaluation of Bids, the Employer shall determine whether each Bid</p> <ul style="list-style-type: none"> <li>(a) meets the eligibility criteria defined in Clause 2;</li> <li>(b) has been properly signed by the authorized person;</li> <li>(c) is accompanied by the required securities; and</li> <li>(d) is substantially responsive to the requirements of the Bidding documents</li> </ul> <p>20.2 The Employer will do evaluation of the Technical Bids based on Criteria specified in the <b>Section V: Eligibility and Qualification Criteria</b></p>
<p><b>21. Evaluation and Comparison of Bids</b></p>	<p>21.1 In evaluating the Bids, the Employer shall determine for each Sealed Bid the evaluated Bid Price by adjusting any corrections for errors. Bids shall be checked by the Employer for any arithmetic errors. <b>23. Employer's Right to Accept or Reject</b>	<p>23.1 The Employer reserves the right to accept or reject any Bid or to cancel the bidding process and reject all Bids, at any time prior to the award of the contract, without assigning any reasons whatsoever.</p>

Notification of Award and Signing of Agreement</b>	<p>24.1 The Bidder whose bid is accepted shall be notified of the award by the Employer.</p> <p>24.2 The notification (hereafter called the “Letter of Acceptance”) to the successful Bidder shall state the sum that the Bidder shall pay the Employer in the execution and completion of the contract. <b>26. Corrupt or Fraudulent Practices</b>	<p>26.1 The Employer shall reject a bid for award if it determines that the Bidder recommended for award of contract has engaged in corrupt or fraudulent practices in competing for the contract in question.</p>

## **SECTION – V: Eligibility and Qualification Criteria**

### **1. Introduction**

The All-Nepal Football Association (ANFA) invites sealed proposals from qualified, reputable, and experienced firms for acquiring Title Sponsorship Right, Marketing, Broadcasting & Digital Rights of the Martyr's Memorial Women's League 2025 for a period of **one season**.

The commercial rights package includes:

1. **Title Sponsorship Rights**
2. **Marketing & Advertising Rights**
3. **Broadcasting Rights**
4. **Digital Media Rights**

This RFP outlines the scope of rights, eligibility requirements, submission procedures, and evaluation criteria.

### **2. Objectives of the RFP**

ANFA seeks to:

- Maximize the commercial value of the ANFA National League 2082
- Partner with a credible and capable entity to enhance revenue, exposure, and fan engagement.
- Ensure transparent and competitive procurement of commercial rights.
- Promote long-term sustainability of Nepali football.

### **3. Scope of Rights**

#### **A. Title Sponsorship Rights**

The successful bidder shall receive:

- Exclusive naming rights for the league (e.g., “XYZ Martyr's Memorial Women's League 2025”).
- Logo integration across all league-related communications, kits, boards, and digital platforms.
- Co-branding rights with ANFA as per the approved brand guidelines.

#### **B. Marketing & Advertising Rights**

- Exclusive on-ground advertising rights (LED boards, static boards, backdrop, arch gates, press conference boards).
- League-wide promotional rights and co-branded marketing campaigns.
- Rights to use ANFA & League Marks for advertising subject to approval.

#### **C. Broadcasting Rights**

- Rights to commercialize TV broadcast.
- Rights to produce all match content or partner with third-party producers.

#### **D. Digital Media Rights**

- Exclusive rights for digital streaming (OTT, YouTube, Facebook, mobile apps).
- Rights for highlights, short-form clips, and digital monetization.
- Development of digital fan engagement products.
