Minimum Requirements:

- a. Accommodation must be on full board Basis (AP plan) Suitable meals three times a day in buffet style of sufficient quantity.
- b. All rooms of the hotel must be comfortable with working Air Conditioning System.
- c. Accommodation facilities (rooms, toilets, hand sanitizer, mask, etc.) and its surroundings must be clean and free from any smell.
- d. Accommodation must be located in an area that is safe from negative and noise pollution.

- j. Ensuring door locks, bathroom locks are functional.
- k. Allocating same gender rooms is compulsory.

- m. Ensuring TV channels and multimedia access are child safe and children friendly.
- n. Ensuring no unauthorized person gets access to accommodation.
- o. Ensuring no exposure/accessibility to self-harming tool and/or substance.

> Other Terms and Conditions

- Hotel must be situated in a suitable place as determined by ANFA considering the
 accessibility to practice Stadium, Match Stadium and tournament location within the listed
 districts above. ANFA has the right to evaluate the proposal depending on the location of the
 service provider.
- Having rooming details of players and officials available to the hotel and accessible for ANFA during the stay at the hotel is a must.
- Minimum Requirement criteria must be ensured by the service provider at no additional cost to ANFA.
- The selected hotel will be required to enter into a formal agreement with ANFA.
- For Evaluation purposes the bidder is required to fill out all the price details above in both
